First is the monthly newspaper, the Klarion, which is hand delivered to every home in Kern City. If you take the time to look through it, you'll find some helpful information.

We also mail a package every year to every homeowner that provides information on the annual budget, elections, collection policy, and much more, including members' rights in an HOA.

We also post announcements around the common area. That is the area just north of Sundale from the parking lot to north of the library. There is a glass case on the streetside of the office, and there are bulletin boards in the Town Hall, the library (by the computers) and across from the community room. The bulletin board in the library has financial information and board minutes on it.

DRAFT KCCA'S REGULAR BOARD MEETING MINUTES

December 12, 2023 9:00 a.m.
The meeting will be videotaped and recorded. The tape recording will be erased after the minutes are done.

I. CALL TO ORDER:

- a. Welcome: President Brad Seymour called the meeting to order at 9:01 a.m. Other directors present: Buster Beebe, Donna Hansen McMillin, Kelley Lee, Joe Newton, Carol Ann Toms, and Jill Wolf and Manager Jill Foley. President Seymour welcomed attendees and member Roger Kirby led the flag salute.
- **b.** Announcements: President Seymour stated the board would not take action on any items until next year when the new board will be seated. Last month an executive board meeting was held regarding personnel. The new board members were provided information regarding their director roles, and the board chose areas of responsibility.
- **II. MINUTES**: Director Hansen McMillin asked if there were any corrections to the Nov. 14, 2023 regular board and annual meeting minutes. There were none so the minutes were accepted as presented.
- HII. TREASURER'S REPORT: Director Hansen McMillin reported that as of Nov. 30, 2023, the Checking Account had \$18,420.28. There is \$481.16 of the checking account money that is in a Money Market Account that earns 2% interest. There is \$363,877.00 of our Reserve Account in a nine-month CD which earns 4% at Mechanics Bank. Therefore, the total in Mechanics Bank as of Nov. 30, 2023 was \$382,778.44.

At Valley Strong there is \$133,624.10 of the swimming pool money in a nine-month CD earning 4.150 % interest. In Alta One, the 10-month CD earning 4.84% interest, has \$245,813.61. Between the three banking institutions, there is \$762,216.15.

IV. MANAGER'S REPORT: Manager Foley reported the following: The deadline to turn

in letters to the editor or classified ads for the Klarion is Wednesday, Dec. 13th, by noon. She reminded everyone that if they wanted something in the Klarion it needed to be in the office no later than the 15th of the month for next month's issue. The 2024 assessments bill and the Annual Policy Statement package were mailed out last month so if you haven't received yours, please contact the office right away. Monthly payments can be made so please contact Jennifer in the office if you want to do that. We were sad to hear of the passing of Bernice Fiolle. Manager Foley said the office appreciates letting it know when someone passes away.

Cinnamon rolls will be available for pickup on Thursday between 12:00-2:00, in front of the office.

V. COMMITTEE REPORTS:

- a. Pool Director Lee stated the pool is open all year round for swimming, but it is not heated in the winter and is cold. She plans to do research as to what kind of heating system might work for the pool. Director Lee is also working on adult activities to have during the summer around the pool. President Seymour said they would be getting bids on replacing the grout in the pool as the tile doesn't need to be replaced and it is felt the algae hides behind the tiles where the grout is worn down. The pool will need to be emptied for that, and the pool lights will be checked, the lines re-painted on the bottom of the pool, and it will be checked for other issues that can be addressed while the pool is empty.
- **b. Inside Maintenance** Director Wolf reported the heater is not working in the sewing room and a part has been ordered. In the meantime, two portable heaters are in the room to help keep it warm. The 'auto' door for the library broke and will be repaired on Thursday. The exercise room equipment had its quarterly inspection and no issues were found.
- c. Outside Maintenance President Seymour

thanked member Daryl Wolf and Director Wolf for repairing broken sprinklers. After the first of the year a sprinkler company will be under contract for \$155 a month to monitor the sprinklers, parts will be an extra cost. President Seymour said that starting in January, the lawn service will change to Valley Lawn Service.

- d. RV Storage Director Beebe reported there are four spaces with non-recreational vehicles in them, and they are being addressed. After the first of the year, he will order a load of gravel and have it dumped at the front of the lot for people to use to help level low spots. He thanked Roger Kirby for leaving the RV Storage area in such good shape at the end of his tenure as a board member.
- e. Special Projects Director Toms reminded everyone about the cinnamon roll pick-up on Thursday. She said the last community ride for the year was held this month. There were eight riders, but they had a great time. The next ride will be sometime in the spring. Director Toms thanked the Social Club for making the Town Hall look so good with all the Christmas decorations.
- f. Library Speaking about the library, member Donna Tyner said there are a lot of Christmas cards available as well as calendars. She said the library donated calendars to "Christmas for Seniors," which she said is very worthwhile since all the donated items go to Kern City residents. She also thanked the Social Club for the donation of the lovely poinsettia in the foyer. She confirmed that the Bakersfield puzzle was not completed and encouraged residents to come in and help put it together. President Seymour reported the Lorna Long sign is now hanging in the library and encouraged residents to go to the library to check it out.

VI. OLD BUSINESS: None – President Seymour said New Business will be the last item on the agenda this time.

I am not a connoisseur of great art, but from time to time a painting or picture will really speak a clear, strong message to me. Some time ago I saw a picture of an old burned-out mountain shack. All that remained was the chimney...the charred debris of what had been that family's sole possession. In front of this destroyed home stood an old grand-father-looking man dressed only in his underclothes with a small boy clutching a pair of patched overalls. It was evident that the child was crying. Beneath the picture were the words which the artist felt the old man was speaking to the boy. They were simple words, yet they presented a profound theology and philosophy of life. Those words were, "Hush child, God ain't dead!"

That vivid picture of that burned-out mountain shack, that old man, the weeping child, and those words "God ain't dead!" keep returning to my mind. Instead of it being a reminder of the despair of life, it has come to be a reminder of hope! I need reminders that there is hope in this world. In the midst of all of life's troubles and failures, I need mental pictures to remind me that all is not lost as long as God is alive and in control of His world. (When God Was Taken Captive, W. Aldrich, Multnomah, 1989, p. 24.)

What an incredible and much needed illustration for us to remember as we enter this new year. Life is filled with ups and downs. We see trouble and turmoil around us from time to time, but there is a God who cares and is by our side. Moses had led the children of Israel out of Egypt and was to take them into the Promised Land. Moses wanted to know who God was going to send with him to lead the way and God told him in Ex.33:14, "My presence will go with you, and I will give you rest" (NIV).

To the prophet Isaiah, God said, "When you pass through the waters, I will be there with you ..." (43:2).

I would like to encourage you, that no matter what you go through in this new year, God ain't dead! Just call on Him as you need Him. As in Psalms 145:15, "The Lord is near to all who call on him, to all who call on him in truth."



Compliance

Here are some of the restrictions Kern City has that relate to complaints the office has received recently. We appreciate everyone's efforts to comply.

Declaration of Restrictions

Trailers, RVs

Section 1,H,7. Effective Jan 1, 2014. No house trailer, utility trailer, boat on or off trailer, truck bed camper, motor home, recreational vehicle (commonly called an "RV") or other similar mobile accommodation (the "Mobile Accommodation") may be allowed on any lot or on the street to be occupied as living quarters for anyone for a period of more than seventy-two (72) hours. Any unoccupied Mobile Accommodation must be maintained at least twenty-five (25) feet from the front lot line, except that they may be temporarily closer than the aforementioned twenty-five (25) foot restriction for not more than forty-eight (48) hours for loading, unloading, washing, and other routine preparation.

> A. Commercial/Large Vehicles: Effective Jan 1, 2014. Commercial and large trucks and vans - those rated over one ton - with the exception of pickup trucks, cannot be parked on streets, in driveways or on Kern City lots unless they are at least 25 feet back from the street and not visible from the street and golf course. Such a vehicle may be parked inside a garage or carport or in a rear fenced yard not on the golf course as long as it is parked on concrete. Vehicles actively engaged in unloading of persons, goods, or merchandise shall be allowed to complete their business.

Vehicles

Section 1H,14A: The number of operable vehicles permitted for each Owner to allow to be on his or her lot at any one time is three (3). Inoperative vehicles and vehicles not currently licensed must be removed within thirty (30) days.

Noise, Nuisance

Section 1H,15. No noxious, offensive or illegal activities shall be conducted within Kern City. Nothing shall be done on or within Kern City that may be or may become an annoyance or nuisance to the residents or Owners, or that in any way interferes with the quiet enjoyment of residents or Owners.

Garbage containers

Section 1H,14A: No rubbish or debris of any kind shall be placed or permitted to accumulate on or adjacent to any lot, and no odors (excepting commercially sold manure when used as a lawn fertilizer) shall be permitted to arise or emit from any lot, so as to render any such lot or any part of it, or any activity on it, unsanitary, unsightly, offensive, or detrimental to any other lot or the Common Area in the vicinity of the lot or to the occupants of such other lots. Trash, garbage and other waste shall be kept only in sanitary containers and shall be regularly collected or shall be deposited in bins or other trash collection receptacles located throughout Kern City and intended for trash collection purposes. No Owner shall permit or cause any trash or refuse to be kept within any part of Kern City other than in customary receptacles. Except on the scheduled day for trash pick up, these receptacles shall be located only in places specifically designated for such purposes.


