Ward 6 Councilmember Zach
Bashirtash visited
Kern City in October
to discuss the need
for a large city sewer
repair costing approximately \$1.3 billion,
and he will be back at
6:00 p.m. on Wednesday, Dec. 3, 2025,

to ask your opinions on how residents should pay the costs.

Many Kern City members and other Bakersfield property owners decried the \$950 rate increase last spring as being



too high an amount to pay in one year so this time the city council is asking property owners what their opinions are about how to raise the needed money.

Councilman Bashirtash, Director of Water Resources Kristina Budak, and

Assistant Water Director Evette Roldan explained the dire state of the sewer system and the need to catch up with repairs. They said the system should have been



DRAFT KCCA'S REGULAR BOARD MEETING MINUTES

November 11, 2025, 5:30 p.m.
The meeting will be videotaped and recorded.
The tape recording will be erased
after the minutes are done.

I. CALL TO ORDER:

- **a. Welcome:** President Seymour called the meeting to order at 5:30 p.m. Other directors present: Buster Beebe, Kelley Lee, Ilene Schechter, Darryl Slavin, Donna Tyner and Jill Wolf and Manager Jill Foley. President Seymour welcomed attendees, and Buster Beebe led the flag salute.
- **b. Announcements:** President Seymour welcomed everyone to the Board Meeting and the Annual Meeting which will follow immediately afterwards. Director Beebe then thanked all the veterans in attendance and acknowledged each person and military branch. He also thanked the wives who had supported the veterans while they were in service.

President Seymour stated that the election ballot count for new directors would start when the Annual Meeting is convened. He also stated there was an Executive Board Meeting to discuss the October vote on the CD at Mechanics Bank, and Director Tyner will discuss that when she gives her report.

II. MINUTES: Director Tyner asked if there were any corrections to the Oct. 14, 2025 minutes. There were none so the minutes were accepted as presented.

III. TREASURER'S REPORT: Director Tyner reported that as of Oct. 31, 2025, the Checking Account had \$24,475.76. There is \$127,584.82 of the checking account money in a Money Market Account at Mechanics Bank. Therefore, the total in Mechanics Bank as of Oct. 31, 2025 is \$152,060.58.

At Valley Strong there is \$104,100.39 in a Money Market account. In the Edward

Jones account, there is \$230,027.60 in a CD, \$60,046.80 in a CD and \$138,001.38 in another CD. There is also \$234,198.99 in a Money Market account. The total in Edward Jones is \$662,274.77. Between the three banking institutions there is \$918,435.74.

Director Tyner reported that at the October meeting, the board voted to renew the maturing \$138,001.38 CD at Mechanics Bank. After listening to members concern, an Executive Board Meeting was held and the October vote on renewing the CD at Mechanics Bank was rescinded. The board then voted on moving the \$138,001.38 into a nine-month 3.75% interest CD at Edward Jones.

IV. MANAGER'S REPORT: Manager Foley reported the deadline to turn in Letters to the Editor or classified ads is Friday, Nov. 15, by noon for the December Klarion. The Annual Disclosure which discuss homeowners' rights in Kern City, along with the 2026 assessment invoice, will be mailed out at the end of this month. If a homeowner needs to break up payments, monthly payments are accepted with at least \$50 per month paid with the entire assessment paid off by October 2026. Manager Foley asked homeowners not to pay the assessment until they have received an invoice. The office has not heard of anyone passing and appreciates the office being notified when a resident passes away.

V. COMMITTEE REPORTS: Will be Shared at the December Meeting

VII. NEW BUSINESS:

a. Action on Maturing CD at Edward Jones: Director Tyner stated a CD at Edward Jones will mature on Nov. 18. Director Tyner made a motion to renew the CD at Edward Jones when it matures into a six-month CD earning 3.75%. Vote: Passed, unanimous.

- **b. Action on Approving 2026 Budget:** President Seymour stated the Budget Committee recommended keeping the 2026 assessment at \$525. Director Tyner made a motion to accept the 2026 yearly assessment of \$525. Vote: Passed, unanimous.
- **c. Key to Kern City:** President Seymour and Social Club President Terry Wirsum announced Rose Tessandori as the 2025 Key to Kern City recipient. She was praised for her years of dedication and involvement in Kern City.
- **X. ADJOURNMENT** President Seymour adjourned the meeting at 5:47 p.m. The Annual Meeting will begin immediately after the Board Meeting.

She was born in Madera, CA. and moved to Bakersfield in 1944 while in her teens. She met her husband here and they were married over 65 years.


They had two sons and a daughter. One son lives in Bakersfield and her daughter actually lives in Kern City, and the other son lives out

of town. When asked how many grandchildren and great grandchildren she had, the answer was "lots." Lol.



Therefore, the councilman and city leaders are educating the public and offering different ways to pay for the sewer costs.
