

# PG&E requires repair on some electrical wires

PG&E recently notified a few of our residents that the insulation on one of the electrical wires going to their properties must be repaired or replaced. This does NOT affect properties that have their wiring underground. This wire is located at the weather hub on the roof, and the repair is only necessary if a resident receives a letter from PG&E or notices that its wire insulation has frayed.

According to PG&E, it is responsible for the wire from its power line to the weather head, and the owner of the property is responsible for the wire from the weather head to

the electrical panel.

Residents must pay for any work needed on their own line. If the insulation is no longer completely covering the wire it is a safety hazard for its workers and the property. PG&E is requesting that any resident who re-

## Feral cats get TNRed, shots for health

Board President Brad Seymour and a crew of six more members took 17 cats to Critters Without Litters last month to be TNRed (Trap, Neuter and Release) and given shots to prevent diseases. Seymour said the city council passed a law a few years ago that requires feral cats to be neutered then returned to where they were trapped and released there.

"This is the second time we've done this and it is a little bit of a complicated project," said Seymour.

"We have to coordinate taking the cats to Critters, complete forms, log each trap cage and the address where it's set out, then collect the cats the next day. We then make sure they're safe and cover the

## President's message

#### Hello Kern City,

This message is to inform and help educate all of us to the advantages and/or disadvantages of transitioning from a self-managed HOA to a Property Management Company.

A couple quick facts about KCCA. 1. Our properties that are out of compliance have been reduced since 1/1/25 by approximately 50%. 2. KCCA has no control over the banks that are in control of the residential properties that were not properly set up for succession (i.e. through wills, probate, or reverse mortgages). 3. The Great State of California has really taken away a lot of the HOAs' ability to manage and enforce rules and regulations.

Advantages of Self-Managed HOAs vs. Property Management Companies:

Homeowner associations (HOAs) play an essential role in maintaining community standards, property values, and neighborhood harmony. One of the most important decisions any HOA board must make is whether to hire a professional property management company or operate as a self-managed association.

While property management companies offer convenience and professional expertise, self-managed HOAs can enjoy significant advantages in terms of cost savings, community engagement, and control.

1. Cost Efficiency and Financial Savings -- The most immediate advantage of a self-managed HOA (KCCA) is financial. Property management companies typically

charge substantial monthly or annual fees, which can account for a large portion of an HOA's budget. By eliminating management company fees, self-managed associations can direct those funds toward community improvements, maintenance, or reserve savings. This can result in lower assessments for homeowners and more flexibility in addressing community needs. Self-managed boards can also monitor spending more closely and ensure every dollar is used in the community's best interest. Without a third party in control of the finances, there is less risk of unnecessary expenditures or markups on vendor services. Board members, who are also homeowners, are naturally motivated to keep costs low while maintaining property values.

- 2. Greater Transparency and Accountability: In a self-managed HOA, all decisions -- from budget planning to rule enforcement -- are made directly by community members. This structure fosters transparency and accountability. Homeowners can see where their money goes and how decisions are made, and they often feel more confident knowing that those making the decisions share the same stake in the community's success. Without a management company acting as a middleman, there is less chance of miscommunication or delays in relaying important information. Board members can provide direct responses to residents, resolve issues more quickly, and maintain open channels of communication through meetings, newsletters, or digital platforms.
- 3. Stronger Community Engagement and Connection: Self-managed HOAs tend to have stronger community bonds. Because homeowners volunteer their time to serve on the board or committees, they become more invested in the well-being of their neighborhoods. This participation encourages collaboration and pride among residents, fostering a sense of unity and shared responsibility. When residents know their board members personally, they are more likely to voice concerns, offer constructive suggestions, and participate in community events. A self-managed HOA often feels more approachable and responsive, helping reduce the "us versus them" mentality that sometimes exists in professionally managed associations.
- 4. Direct Control and Decision-Making Flexibility: One of the biggest frustrations some HOAs face with management companies is the bureaucracy that can accompany even simple decisions. Management firms may have their own policies, timelines, and preferred vendors that limit an HOA's flexibility. In contrast, a self-managed board can act quickly to address issues, approve

## DRAFT KCCA'S REGULAR BOARD MEETING MINUTES

The meeting will be videotaped and recorded. The tape recording will be erased after the minutes are done.

#### I. CALL TO ORDER:

- **a. Welcome**: President Seymour called the meeting to order at 9:00 a.m. Other directors present: Buster Beebe, Kelley Lee, Ilene Schechter, Darryl Slavin, Donna Tyner and Jill Wolf and Manager Jill Foley. President Seymour welcomed attendees, and Sharon Parks led the flag salute.
- **b.** Announcements: President Seymour welcomed everyone to the meeting. He stated the lawn will be seeded with winter rye on Friday. He reported the ballots for the election of new board members have been mailed out and the results of the election will be announced at the Annual Meeting, right after the regular board meeting on Nov. 11, Veterans Day. He said there are five candidates who are running: Gary Corbell, Donna Hansen McMillin, Joe Newton, Darryl Slavin (running for a second term) and Carol Ann Toms. He thanked them for being willing to donate their time to Kern City. Members whose terms expire include Brad Seymour, Kelley Lee, Darryl Slavin and Jill Wolf.
- **II. MINUTES:** Director Tyner asked if there were any corrections to the Sept. 9, 2025 minutes. There were none so the minutes were accepted as presented.
- III. TREASURER'S REPORT: Director Tyner reported that as of Sept. 30, 2025, the Checking Account had \$27,866.20. There was \$172,398.07 of the checking account money in a Money Market Account and \$137,770.59 of our reserve in a CD at Mechanics Bank. Therefore, the total in Mechanics Bank as of Sept. 30, 2025 was \$338,034.86.

At Valley Strong we had \$103,817.96 in a Money Market account. At Edward Jones, we had \$230,013.80 in one CD, \$60,009.00

in another CD and \$233,225.22 in a Money Market account. The total in Edward Jones was \$523,248.02. Between the three banking institutions, there was \$965,100,84 on Sept. 30.

Foley reported the deadline to turn in Letters to the Editor or classified ads is tomorrow by noon for the November *Klarion*. The Annual Policy Statement, which discusses your rights in Kern City, along with the 2026 assessment invoice will be mailed out at the end of November. The 2026 Budget does not include an increase in the assessment; it is still \$525 for the year. Homeowners can make monthly payments but must contact the office first. She requested that assessments not be paid until the bill has been received by the homeowner. The office has learned of the passing of Andy Darby and Linda Reiland.

#### **V. COMMITTEE REPORTS:**

- **a. Pool** Director Lee said the pool is too cold for most people, but it is maintained for all the 'polar bears' in the community. The water fountains and the waterfall have been turned off for the winter months.
- **b. Inside Maintenance** -- Director Wolf said there was not any inside maintenance needed last month. She said the gardening club is cleaning out the flower beds and will be planting the fall/winter flowers instead of having the gardener do it.
- **c.** Compliance Director Wolf reported the office was addressing trailers parked out front for longer than the 72 hours allowed. It is also notifying homeowners whose sprinklers are running into the street.
- **d. Outside Maintenance** Director Slavin stated Custom Build Construction was working on the Town Hall walls last weekend. Director Slavin replaced the water filters for the drinking fountains. He also reported Grogan

Mechanical will be out tomorrow to service all the air conditioning/heating units, and Valley Lawn Service will be seeding the lawn with rye grass on Friday.

- **e. RV Storage** -- Director Beebe reported he raked up pine needles in the RV Storage yard and Daryl Wolf and Director Wolf bagged them up and threw them away. He thanked them and Joe Newton for all their help with the RV Storage.
- **f. Special Projects** Director Tyner stated the Key to Kern City is the next special project. The Kern City Board and the Social Club will nominate one or more people for the Key to Kern City, and it will be awarded at the Annual Meeting. The 'Early Bird' dinner at the 19<sup>th</sup> Hole is Oct. 24<sup>th</sup> from 4:00 6:00 p.m. and will be a house-made chicken pot pie dinner for \$15.95 with reservations by Oct. 23. Without reservations the dinner is \$17.95.
- **g**. **Library** -- Director Tyner said she would love some new books and encouraged residents to come in and work on a puzzle.
- **h. Local Associations** Director Schechter reported that she, President Seymour and Director Wolf have been attending the local associations' yearly meetings to help out where needed since KCCA is the master HOA.







In his book FOLK PSALMS OF FAITH, Ray Stedman tells of an experience H.A. Ironside had in a crowded restaurant. As I walk or drive around our great community, I have noticed many US flags not displayed properly. Currently, much less, but a few nevertheless.

I have included the relevant parts of Sections 174 and 176 of the US Flag Code for reference:

Randall Dickow

USAF Vet, 1965-71

- §174. Time and occasions for display
- (a) Display on buildings and stationary flagstaffs in open; night display

It is the universal custom to display the flag only from sunrise to sunset on buildings and on stationary flagstaffs in the open. However, when a patriotic effect is desired, the flag may be displayed twenty-four hours a day if properly illuminated during the hours of darkness...

- (c) Inclement weather
- The flag should not be displayed on days when the weather is inclement, except when an all weather flag is displayed.
- §176. Respect for flag
- No disrespect should be shown to the flag of the United States of America; ....
- (e) The flag should never be fastened, displayed, used, or stored in such a manner as to permit it to be easily torn, soiled, or damaged in any way.
- (k) The flag, when it is in such condition that it is no longer a fitting emblem for display, should be destroyed in a dignified way, preferably by burning.

traps with a towel and give them water before taking them to Critters for treatment. Afterward we bring all the cats back to each address where they were picked up and release the cats there.

"We've received many complaints about people feeding feral cats because they often damage peoples' outdoor furniture, properties and gardens, and the food put out for them attracts skunks, kit foxes, raccoons, and possums. Also, we had hoped that more residents would help with our TNR projects, but at least we were able to have 17 cats

neutered and treated this time."

Last year, several residents helped set out 30 traps and 23 cats were TNRed. This year 24 traps were put out and 18 were caught. One was released because it had a notched ear signifying it had been TNRed.

The crew doing the heavy work included Seymour, Directors Darryl Slavin and Jill Wolf, and members Patti Reed, Leigh Schroyer, Tedi Smart and Daryl Wolf.

"I'm so grateful to them for all their help," Seymour said. "Lifting, carrying, cleaning, while doing it late at night and early in the morning -- that takes some effort. And I'd like to thank Darren Leist for washing all the towels afterward plus some other residents who offered ideas and knowledge.

"I also appreciate the residents who allowed us to put traps on their properties. This is a project that actually is a humane way to treat the cats, and hopefully it will cut down on the number of ferals in the future."

projects, or adapt policies based on the community's unique needs. Direct control also ensures that the board's priorities align perfectly with homeowner interests, rather than with a company's profit motives or standard operating procedures. This autonomy can lead to more thoughtful, personalized governance and the ability to tailor community rules, maintenance plans, and budgets to fit local circumstances.

- 5. Enhanced Sense of Ownership and Pride: When homeowners take an active role in managing their community, they develop a deeper appreciation for the work that goes into maintaining it. Serving on a self-managed board encourages civic responsibility and helps residents see the tangible results of their efforts -- whether it's improved land-scaping, upgraded amenities, or stronger neighborhood relationships. This sense of ownership often translates to better compliance with community rules, more volunteer participation, and higher property values over time. Homeowners who feel connected to their neighborhood are more likely to care for their properties and contribute positively to the community culture.
- 6. Tailored Vendor and Maintenance Relationships: Self-managed HOAs can build direct, long-term relationships with local vendors and service providers. Without an intermediary management company, the

board can negotiate contracts directly, seek multiple bids, and ensure quality control. These relationships can lead to more personalized service and potential cost savings through loyalty and transparency.

Conclusion: While professional property management companies can offer convenience, experience, and structure—especially for large or complex communities—a self-managed HOA provides unmatched financial control, flexibility, and community spirit. The advantages of lower costs, increased transparency, direct decision-making, and stronger homeowner engagement make self-management an appealing choice for many associations. With organization, clear communication, and dedicated volunteers, a self-managed HOA can operate efficiently while fostering a deeper sense of pride and unity among residents.

Please keep in mind that I have done plenty of research into this subject, and I'm very forthcoming and honest about what I have learned. I have talked to the CEO of a resident- recommended Property Management Company, and she has no clients in Kern County, and the largest HOA her company has managed was a 300-unit HOA (only about 25% of what KCCA is). She admitted that they have never managed any HOAs with sub-HOA's (local associations). KCCA has 17 sub-HOA's and an intermediary management association (KCAI) that still is part of KCCA. FYI, all HOA's within KCCA's purview must abide by the Master Association's (KERN CITY CIVIC ASSOCIATION) CC&Rs.
